On average, the cost of living in Spain is over 20-25% lower than in the U.K. This means your retirement savings go much further.

With more than 300 days of sunshine a year in some regions, you can enjoy a comfortable climate nearly year-round.

3-Delicious Cuisine:

Spain is a food lover's paradise—paella, tapas, fresh seafood and fine wine await.

4-Thriving Expat Community:

With tens of thousands of British expats already living in Spain, especially along the Costa del Sol, you'll never be too far from a fellow Brit to connect with.

Visa Options for Retiring in Spain

The Non-Lucrative Visa (NLV) is the go-to choice for most retirees.



1- Requirements:

- (i)- Be a non-EU citizen
- (ii)- Show proof of sufficient income or savings (currently €28,800/year or ~\$31,050 for a single applicant; €7,200/year per dependent)
- (ii)- Show proof of sufficient income or savings (currently €28,800/year or ~\$31,050 for a single applicant; €7,200/ year per dependent)
- (iv)- A clean criminal record and medical certificate
- (v)- Proof of accommodation in Spain

2- Validity:

- (i)- Initially valid for 1 year
- (ii)- Renewable for two 2 year periods
- (ii)- After 5 years, you can apply for permanent residency

Pro tip: If you're not yet retired but living off savings, you can still apply, as long as you don't plan to work.

Understanding Taxes as a Retiree in Spain



Taxes can be one of the most confusing parts of retiring abroad, but they don't have to be.



Spain's Tax System:

Once you spend 183+ days per year in Spain, you become a tax resident and must report worldwide income, including U.S. retirement income.

2025 income tax rates in Spain:

Income (EUR)	Tax Rate
• Up to €12,450	• 19%
• €12,450 - €20,200	• 24%
• €20,200 - €35,200	• 30 %
• €35,200 - €60,000	• 37%
• €60,000 - €300,00	• 45 %
• Over €300,000	• 47%

Spain also taxes capital gains and savings income at rates between 19% and 30%.



Healthcare for Retirees in Spain

Spain's healthcare system is ranked among the best in the world, offering high-quality care that's also affordable. If you're coming on a non-lucrative visa, you'll need to start with private insurance. The good news is that private insurance costs are much lower than in the US, typically ranging from around €30 to €180 per month, depending on your age and level of cover.

Having private insurance means you'll have access to English-speaking doctors in larger cities, shorter wait times, and modern, well-equipped hospitals. After living in Spain for five years, you can apply for permanent residency, which allows you to join the public healthcare system (SNS).



Your monthly budget will depend on your lifestyle and where you live. Here's a general range of typical expenses:

- Rent (1 bedroom, city center): from €600 to €1360
- 2. Rent (1 bedroom, outskirts): from €600 to €950
- 3. Utilities (electricity, water, heating, etc.): from €150 to €300
- 4. Public transport pass: from €20 to €45
- 5. Dinner for two (mid-range restaurant): from €40 to €70
- 6. Private health insurance (average): from €50 to €150

Estimated total monthly budget: from $\in 1,800 - \in 3,500$, depending on the city and your personal lifestyle.
